Stay scam-smart during the merger

Scammers are great at trying to catch people off guard. That includes taking advantage of tax season and when organizations merge or change their logo. To stay safe, check out these tips.

The verify-your-account scam



Be on the lookout for official-looking (and sounding) emails, texts, calls, and social media "from" Wings claiming you must verify your account due to the merger. These are scams. Don't respond or click on any links. Instead, contact Wings directly to validate any suspicious messages.

Verify it's us



As always, if you get a request for your banking or personal information, please protect yourself by verifying our contact information and reaching out to us directly. Scammers make it all too easy to simply click on a phony link within a message or use a false phone number they provide. When in doubt, call Wings directly.

What we never ask for



Keep in mind that Wings will **NEVER contact you and ask for** your digital banking login, PIN, security code, account number, full Social Security number or other sensitive information.

Stay current on the merger progress through our official site **Wings.CUtogether.com**. This may help you know the difference between valid updates and scam attempts. We're happy to help make sure you're banking with us securely.
